It is also certified that adequate clinical material as per norms of the Central Council of Homoeopathic is available with the proposed Medical College. It is further certified that in case the applicant fails to create infrastructure for the Homoeopathic College as per Central Council of Homoeopathic norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the student already admitted in the College with the permission of the Central Government.
